Winterization of vessel includes the following:

- 1. Required amount of non-toxic antifreeze run through engine(s), freshwater system including water tank, holding tank, sump pumps, dockside water connections, water heater, air conditioning, ice maker, etc.
- 2. Fuel stabilizer added to fuel tanks if requested (Yamaha outboards will have a mixture of aviation grade fuel and fogging oil ran through the fuel system)
- 3. Vessel health inspection including batteries, bilge pumps, and transducer
- 4. Disconnection of battery loads

PYC recommends boat owners perform the following prior to PYC beginning work:

- 1. Pump out and flush holding tank *PYC does not provide pump out service
- 2. Empty refrigerators, remove perishables, and valuables *PYC will not be responsible for items left
- 3. Top off fuel tanks
- 4. Ensure all batteries are fully charged

If you require your boat to be out at a specific date, please notify PYC in writing with a requested date and we will try to accommodate your request. If boats need to be moved to access your boat, there may be charges associated to move said boats.
- Mobile service travel is charged at our shop hourly rate (\$179/hr) from PYC to service location, and back to PYC. Mileage charge will be added to final invoice
- 4% Shop Supplies fees added to each invoice
- All work will be billed upon completion to credit card provided
- 1. Pocket Yacht Company is authorized to perform work, including labor, parts and materials for the prices in cash or credit card to be issued to Pocket Yacht Company
- 2. If I fail to pay for the above completed work, I understand Pocket Yacht Company shall have a mechanic's lien upon the vessel to secure payment for the work and I expressly waive all rights to claim exemption under the state laws.
- 3. If collection is made by a suit or any other method required, I agree to pay interest of 18% APR until paid in full, including collection and reasonable attorney fees.
- 4. I agree not to hold Pocket Yacht Company liable for loss or damage to real or personal property caused by theft, fire or any other cause except negligence of Pocket Yacht Company personnel while boat and/or trailer is in for repairs, storage or sale.
- 5. Pocket Yacht Company employees may operate the above-described boat, motor(s) and/or trailer and my motor vehicle for purposes of testing, inspection, or delivery at my risk.
- 6. Pocket Yacht Company reserves the right to substitute parts for those not currently available.
- 7. Storage charges shall be added to all items not picked up within 7 days after notification of completion of service.
- 8. All parts removed shall be discarded unless otherwise specified. If you would like your parts saved, please indicate so
